*** Colorado Medicaid eligibility is determined on a monthly basis. If your income or circumstances change, your eligibility could change. In December, Colorado Medicaid began enrolling individuals who had previously applied and those who were on a waitlist for coverage that appeared to have qualified for the Medicaid expansion. **The numbers in the chart reflect those who are actually enrolled (previous numbers reported were estimates of those eligible). The individuals enrolled are getting coverage effective January 1, 2014. Individuals who are not eligible for Medicaid because they are over income are referred to Connect for Health Colorado as they may benefit from financial assistance offered through the marketplace.**
